Tatianna Pelletier, recipient of the 2022 Crowe MacKay LLP No Limits Award and the 2022 TELUS Award for Indigenous Post-Secondary Success

Not many people know where their careers will take them. Some happen to stumble upon a career. Others were born for theirs.

For Tatianna Pelletier, her career path is more of a calling.

From a young age, Tatianna has always felt a calling to lend a hand and give back to her Indigenous community that has given her so much. Being a Métis woman and the first person in her family to receive a post-secondary degree, she also hopes to be a role model – especially for her son – and inspire others who have faced adversity to continue working towards their dreams.

She believes the CPA career path will help her accomplish those goals.

"This may sound a little weird, but ever since I was 12 or 13, I knew I wanted to be an accountant, even though I didn't grow up surrounded by accountants or had any idea of the journey to receive the CPA designation," she says. "So I really don't remember where that came from. All I know is that I am close to achieving my aspirations, and I am extremely grateful for the journey."



Tatianna plans to use what she has learned to build an accounting firm that values and aims to work with Indigenous businesses and communities, and create a safe space that provides personalized learning opportunities for Indigenous students and graduates. Whether it's through mentoring or volunteering, she hopes that her work behind the scenes will provide a positive reinforcement to the world around her.

"My ultimate goal," she muses, "is that while experiencing my life and career journey, that I am able to help my family, our communities, and our economy in many personalized ways."

A LONG AND REWARDING ROAD

Vanessa Le, recipient of the 2022 CPA Education Foundation Perseverance Award

Life sometimes gets in the way. Dreams interrupted. Goals unfulfilled. Often the easy route is to give up and just keep on keeping on. That wasn't the case for Vanessa Le.

Ever since she was in university, Vanessa wanted to be an accountant, but her journey hasn't been easy. Between moving provinces with her family, to working a fulltime job and being a single parent to three young children, her dream seemed nearly impossible and had to be put on hold. That dream was re-ignited when she learned about the CPA designation and entered the program in 2014, making it her seven-year goal to complete the program.

"I have to admit that it was not an easy task," Vanessa says. "Life has brought on challenges but I kept reminding myself to never give up." And she never did. Aside from not wanting to disappoint herself, she also wanted to set an example for her children to show them "nothing is impossible if you set your mind to it and work hard."

That tenacity and perseverance paid off. Unlike those that enter the profession right out of university, Vanessa is mid-career, balancing a demanding full-time job, being a single parent, and also taking unpaid leave to prepare for each attempt the CFE - the final attempt being in the midst of a global pandemic. Between keeping her children safe and navigating the online/inperson learning uncertainty, she also had to find time to study for her exams. It was perseverance that, amidst all the struggles, is what enabled her to finally pass the CFE.

She says couldn't have done it without the support of the Foundation and its donors, and the many CPAs she's met along the way. "I have met many successful accountants who are leaders in their communities and who inspire me," she says. "Some of them have provided support in my studies, as well as motivating me to complete my designation."



CONFERENCE FOR ACCOUNTING EDUCATORS

The CPA Education Foundation's Conference for Accounting Educators was held on May 13th, 2022. The conference attracted accounting educators from Alberta's post-secondary institutions for a day of discussion of best practices in teaching and learning, and an opportunity to connect with colleagues.

This year's even had nearly 120 representatives from 19 post-secondary institutions logged in to participate in the conference.

Topics of discussion included:

- Incorporating ESG themes into accounting education presented by Dr. Sandip Lalli FCPA, FCMA
- Financial Reporting, Assurance and Sustainability Standards Update presented by Jean-Francois Trepanier CPA auditor, CA, and Lisa French MBA, P.Eng. from CPA Canada
- Data Analytics: Trends and Teaching Creating the Future, Together presented by Shawn Kanungo CPA, CA



THE ALBERTA COLLEGE GRANT

Many of Alberta's post-secondary colleges offer programs that help students in smaller communities earn bachelor's degrees without having to leave their home communities. The CPA Education Foundation believes that supporting these colleges will not only greatly benefit students, but will also honour the legacy of the Hesje CPA Knowledge Centre's founder and namesake, the late Brian Hesje FCPA, FCA. Brian had a passion for supporting students in small towns and farming communities who seldom had the same opportunities as students in big cities. The Alberta College Grant was introduced to provide one-time financial support to Alberta colleges offering direct transfer pathways to degree-granting institutions approved for entry into the CPA Professional Education Program (CPA PEP). A portion of the grants awarded from the Knowledge Centre were directed to support technology upgrades for colleges that primarily serve students from smaller communities.

YOUR CAREER IN ACCOUNTING

In 2019, the Foundation launched its Stepping Up campaign with a goal to raise \$150,000 to help Alberta high school students overcome barriers in pursuing business education and careers in accounting. These goals were based on the following program pillars:

- **Awards**—Support for high school students entering a business faculty at an Alberta post-secondary institution;
- **Resources**—Access to physical and digital resources that help students learn about the profession and the career possibilities that exist as a CPA and;
- **Outreach**—Connect students to the Foundation and the CPA profession.

The past two years were filled with meaningful programming under the Stepping Up umbrella, and the Foundation is proud of the support provided to high schools and their students across the province in 2022.

HELPING STUDENTS DISCOVER THEIR ENTREPRENEURIAL PATH

4-H ALBERTA TRAILBLAZERS PROGRAM In collaboration with the Hesje CPA Knowledge Centre, the CPA Education Foundation partnered with 4-H Alberta to create Trailblazers, a youth program that introduces senior 4-H members and future entrepreneurs to the basics of entrepreneurship. The program included handson activities and engaging guest speakers on topics ranging from financial literacy to marketing and operations, with time allotted for members to create their business proposals and pitch their ideas. Even though the in-person workshop component of the program was postponed due to COVID-19, the program received positive reviews with a 98% satisfaction rate.

IMPROVING ACCESS TO EDUCATIONAL OPPORTUNITIES

THE STEPPING UP RURAL HIGH SCHOOL GRANT

The Rural High School Grant was established as part of the CPA Education Foundation's Stepping Up initiative. Funded in partnership with the Hesje CPA Knowledge Centre, this one-time \$10,000 grant supported academic resources and educational initiatives that enhanced student learning in rural Alberta communities.

Since it was established in 2021, the grant has been awarded to five schools and school divisions across Alberta for their projects aimed at increasing access to educational opportunities and setting students up for success. Most recently, funds were awarded to Drumheller Valley Secondary School in Drumheller, Harry Collinge High School in Hinton, and the Livingstone Range School Division in Fort Macleod.

ENHANCING THE ACCOUNTING EDUCATIONAL JOURNEY

UNIVERSITY OF LETHBRIDGE'S DHILLON SCHOOL OF BUSINESS INSIGHT SERIES The CPA Education Foundation exists to foster excellence in future CPAs by supporting the work of those, like the University of Lethbridge's Dhillon School of Business, who inspire and develop future CPAs.

Most recently, the Foundation has partnered with the Dhillon School of Business and MNP Lethbridge to help fund their Insight Series, a micro-course seminar program launched in fall of 2022. The six-course program will enhance accounting students' human skills and ensure they're future ready through critical thinking, creativity, adaptability, and collaboration. The Insight Series is open to Dhillon School of Business students, as well as working professionals and community members.

EXPLORING YOUR OPTIONS

JUNIOR ACHIEVEMENT'S WORLD OF CHOICES EVENTS

Junior Achievement's World of Choices events brought students together with career mentors working in a diverse range of professions spanning from accounting to health care and arts. The Foundation was proud to sponsor these events once again in both northern and southern Alberta. The Foundation also sponsored Junior Achievement Northern Alberta's Investment Strategies program. This online program introduces students to the stock market, its relation to our economy, and how it is used to achieve financial goals.

DEVELOPING SKILLS TO GET THE INSIDE TRACK

INSIDE TRACK MICROSITE AND STUDENT AWARDS

After a successful pilot program, the Inside Track, a micro-website for high school students, teachers and parents was officially launched in Spring 2022. Championed by former Foundation Board Chair, Dave Bodnarchuk FCPA, FCA, this business acumen site educates visitors on the many skills and tools that are the foundation of business success.

The main feature of the microsite is a collection of short videos featuring successful CPAs talking about the kinds of skills needed to attain business success, such as financial acumen, leadership, creativity, and business savvy. High school students in grades 10 to 12 were encouraged to watch the videos and submit a short essay about what they learned from the content, which topics/videos mattered the most to them, and what they feel are important qualities for business success.

DONOR SPOTLIGHT: THE WEISS FAMILY

PAYING IT FORWARD FROM PUERTO RICO

With over 26,000 charities and non-profit organizations in Alberta, it can be challenging to decide which organizations to support. For Paula Weiss CPA, CA, and Spencer Weiss CPA, CA, the CPA Education Foundation (Foundation) was an obvious choice.

Paula and Spencer are no strangers to giving back. From sitting on Boards to building houses for Habitat for Humanity, their generosity knows no bounds. "I want our kids to learn how important it is to be involved in their communities and this world. If we show them how to make a difference, they will make a difference," says Paula.

As long-time supporters of ATCO's Employees Participating in Communities program, the Weiss family decided to focus their attention on future business leaders through their support of two high school awards for grade 12 students pursuing business education. "Living in Puerto Rico – as well as coming from families and grandparents who immigrated to Canada, we find ourselves very fortunate. We wanted to ensure that everyone who has dreams to join the profession and pursue their aspirations can," says Spencer. From humble beginnings Paula and Spencer worked hard to put themselves through university, Paula working at ATB and Spencer at Boston Pizza and an accounting firm. However, the pair still graduated with significant student loan debts as a result of migrating from the rural prairies to Edmonton to pursue their career aspirations. They know exactly how challenging it can be to fund educational journeys, and just how valuable scholarships are for struggling students.

Fast forward to today, Paula and Spencer are passionate about paying it forward and encourage other CPAs to give back even if it's

> in smaller amounts. "We both have good jobs. We are very fortunate but we aren't executives and we don't sit on fancy boards. You don't have to be wildly successful to do good. We accountants can all do more to repair some of the massive wrongs in this world," says Paula.

The Weiss family encourage all CPAs to give back in a

way that's manageable for them, whether that's colleagues getting together to fund a Foundation scholarship or participating in a corporate giving challenge matched by their employer.


