John Thorpe reflects on how the designation helped him get to where he is today

When John Thorpe CPA, CMA

graduated from university with a bachelor's degree in marketing, accounting was the furthest thing from his mind. It wasn't that he disliked working with numbers or had no interest in finance—it just wasn't something he focused on. Fast forward a few years into working in the surety industry as an underwriter, however, and John realized he wanted to get the designation to help further his career goals.

"I was looking for ways to broaden my skillset, as well as find a way to differentiate myself from my peers and competitors," says John. "There weren't many people in my company or even across the surety world that had the CPA designation." The designation helped John stand out, and today, more than 13 years after starting with Trisura Guarantee Insurance Company, he is the Regional Vice President, Prairies.

While being in a leadership role has always come naturally to John, whether that was in school or on sports teams, getting the designation helped him develop his technical and soft skills—for example, coaching and public speaking. It also made him a stronger insurance underwriter. "That gave my superiors confidence in my ability to take on more responsibility, and they trusted my decision making," says John.

Becoming a leader is about more than just getting into a leadership position, however. To be a great leader, John recommends that you remain curious and approach situations with an open mind. He also believes the best leaders will take a genuine interest in their coworkers, understand what those coworkers do every day, and figure out how to best support them. And, of course, leaders need to be creative problem solvers who are interested in lifelong learning.

"I think all those things make good leaders," says John. "But I would say leading by listening, being curious, and focusing on the growth and development of your team are what make really good leaders."

John also believes that leaders should constantly look for ways to make themselves better. "I think it's all about continuous learning, finding areas where you think you're maybe not as strong, and trying to improve on them," he says. learning is highly valued, and there's no shortage of strong leaders who pursue professional development to be the best leaders they can be. And while you shouldn't forget about your strengths, improving on your weaknesses will keep you from stagnating and make you a stronger, more well-rounded person. "If you want to be a leader in your business, you can do that," says John. "Taking initiative and showing your employer or your manager that you're interested in being a leader goes a long way."

> Change is constant in life. (Recent events like the COVID-19 pandemic have highlighted that the business environment can shift considerably in a blink of an eye.) Regardless of the reasons behind any changes, professionals need to be adaptable and have a growth mindset; they also need to be ready to learn new skills that enable them to remain employable and continuously bring value to organizations.

Bibitha Thomas CPA has an extensive background in the science field, but when she moved from India to Canada, finding work was initially challenging. "I have a master's degree in chemistry, and I used to work as a research scientist/medicinal chemist for one of the largest contract research organizations in India. I successfully delivered numerous compounds to various pharmaceutical clients all over the world," says Bibitha. "However, during our first four years in Canada, I travelled across the country with my family hoping to find a job."

When Bibitha couldn't find a suitable opportunity, she decided to switch paths. Rather than pursue another career in the science field, she set her sights on becoming a CPA. "I was looking for a fulfilling career, not a job. I wanted to make sure that after completing my studies, I would be able to find a career that provided financial stability and the ability to grow," says Bibitha.

At first glance, science and accounting seem to have nothing in common. But Bibitha, who is currently the Acting Team Leader for Small and Medium Enterprise Audit at Canada Revenue Agency, says some of the soft skills she cultivated as a research scientist are highly valuable in her current role.

"Attention to detail is a big one," says Bibitha. "In my previous career, I conducted lab experiments and

created compounds that formed the building blocks of medications. Small errors in handling these compounds could render them unusable. Similarly, when auditing financial statements, I need to pay attention to every detail because errors can lead to inaccurate adjustments."

Her CPA skills have also provided her with valuable technical skills, boosted her confidence, and given her credibility.

To other professionals considering a career change, Bibitha says, "The journey to becoming a CPA is not an easy one; however, if you believe in yourself and remain determined, your efforts will pay off. Having the designation will create endless opportunities."

the journey to her designation as a way of taking a stand against societal expectations. Ada's mother initially wanted her to become a doctor, but Ada felt differently and decided to try accounting. "I surprised myself when I graduated as the best student and the first female ever in the Accountancy department!" Ada says with a grin.

Ada obtained her first accounting designation in Nigeria. When she and her family moved to Canada, she found herself at the beginning of the designation journey again. She was taken aback. "It was hard not to say, 'Are you for real? Do you know how long ago I was designated?'" remembers Ada.

Ada's life experiences and other life lessons are the basis for the quips in her first book, *101 Quips and Quotes That Will Charge and Change Your Life*, and her other books that make up the 101 Quips and Quotes collection.

In addition to her other hats, Ada is a Certified Leadership Coach. She calls herself "the Diamond Cutter" because she helps people "carve out" and polish their brilliance—just like she did in her life when she started from scratch and gained her designation in Canada. "I love love love helping people discover and deploy—and in some cases, discover and deepen—their brilliance," says Ada.


The CPA designation + your degree (in any discipline) + existing credentials = success!

The CPA Certification Program which consists of the CPA Professional Education Program (CPA PEP), practical experience, and the Common Final Examination (CFE)—is designed to provide future CPAs with the knowledge and skills to succeed in any role they take on.

CPA PEP is a part-time, two-year, post-graduate program consisting of six modules. The modules are delivered through a blend of online and classroom learning, and selfstudy. The CPA Western School of Business (CPAWSB) delivers the program in Western Canada. To qualify for admission to CPA PEP, an applicant must have an undergraduate degree (in any discipline) from a recognized postsecondary institution. Applicants also need to successfully complete any required prerequisites through CPA preparatory courses or a postsecondary institution.
