Investing in homegrown talent Firm's scholarship builds local community

As soon as she became a partner with Lorenz Richer Currie LLP Chartered Accountants in Grande Prairie, Liza Richer CPA, CA approached her partners Doug Currie CPA, CA and Shelley Lorenz CPA, CA with an idea for a scholarship that she had in mind for a while. Convincing them was easy—Doug and Shelley immediately agreed that the act of generosity was the right initiative for the firm.

The trio decided to establish the Lorenz Richer Currie LLP Award through the CPA Education Foundation to support students from Grande Prairie Regional College and Athabasca University wishing to earn a CPA designation.

"Giving other people that chance was the first thing that I wanted to do once I became a partner," Liza says. Supporting local education is important to Liza; the main reason she was able to become a CPA was because she could earn her degree locally without having to move away from her husband and hometown. Now, as an active member of the Grande Prairie Chapter of CPAs (and past President), a supporter of the Grande Prairie Piranhas Swim Club, and a mom of two, she is even more invested in the city where she grew up.

Grande Prairie is one of the largest cities north of Edmonton. Since 2000, it has experienced significant growth due to its strong resource markets in agriculture, forestry, and oil and gas. Located in the heart of the city, Lorenz Richer Currie LLP Chartered Accountants has been operating for over 27 years, meeting the needs of small businesses in the Peace Region. "We pride ourselves on giving excellent personal service to our clients and put a strong focus on the continuing professional development of our staff and partners," explains Doug. Their firm is like a family. "There is a lot of light-heartedness, laughter, and support," says Liza. "That is important to me."


Being invested in their profession and community is also why Doug and Shelley want to support local students.

"I was brought up in a household where giving was the expected thing to do," says Doug. Having moved to Grande Prairie from Saskatchewan in 1995, he has now been married for 32 years, has two daughters, is Treasurer of St. Paul's United Church, and takes part in Grande Prairie Live Theatre. He believes that the award the firm established will help ensure that there are enough qualified CPAs being educated and employed in Grande Prairie to allow retiring CPAs, such as himself, to transition their clients confidently. "Twenty years ago, when the best and the brightest had to go to Edmonton or Calgary to get their degree, few came back to Grande Prairie—with the exception of Shelley!"

Shelley, born and raised in Grande Prairie, had her first articling job at a firm where her father, Marcel M. Joberty CA, was a partner. She and her father later began their own firm, which, with her father's retirement and new partners coming on board, is now Lorenz Richer Currie Chartered Accountants LLP. During her 30+ years as an accountant, Shelley has been an active member of the Grande Prairie Chapter of CPAs, ICAA Distinguished Service Award recipient in 2002, and ambassador for the profession. With an office window overlooking the Grande Prairie Regional College campus, local education has always been top of mind for her: "I am a firm believer in educating locally as it encourages students to also be employed locally and ensures an ongoing addition of new professionals to our community," she says.

By supporting students through the CPA Education Foundation, the team says they are able to focus their support to those entering the profession and help alleviate the financial burden so that students are able to focus on their studies. "We are proud of our profession and through our support we can help to ensure that the best and brightest are able to join and make it even better," says Doug.

The Lorenz Richer Currie LLP Award (\$1,500) is awarded annually to one student in his/her third year of the Bachelor of Commerce or Bachelor of Management degree program at Athabasca University and/or Grande Prairie Regional College. The student must have achieved a minimum grade point average of 2.3 in the previous fall semester (based on a minimum of 12 credits) and must intend to register in the CPA Professional Education Program. A little bit goes a very long way

Award recipient: Jessy Xie

Award: **David Bentley FCPA, FCA and Janet Bentley High School Excellence Award** Funded in collaboration with the Edmonton Community Foundation.



Jessy Xie moved to Canada from YongDing, Fujian, China in 2006. Since moving to Canada, she's seen more of the prairies in the span of 10 years than most born and raised Albertans have in their entire lives. Her family has lived in Canmore, Grande Cache, Grand Prairie, Edson, Consort, and now Red Deer, which they proudly call home.

After receiving the David Bentley FCPA, FCA and Janet Bentley High School Excellence Award, Jessy graduated from Lindsay Thurber High School in 2015 with an International Baccalaureate Diploma.

"Receiving the funding was the first step to help me fulfill my degree in commerce," says Jessy. "University can be an expensive experience, so it allowed me to focus on my studies as I pursue my education in the field of finance."

Because Jessy enjoys working with numbers, she decided that pursuing her CPA would be the best fit for her. "Individuals, businesses, companies, and corporations will always require some sort of financial management and advice," says Jessy. "The demand and opportunities for diverse roles in an accounting career were also the main reasons for my interest." In the Red Deer community, Jessy has taken on many roles in a volunteer capacity, including volunteering at the Red Deer Regional Hospital—distributing meal trays, talking with patients, sanitizing wheelchairs, disposing linen, and helping with whatever nurses needed.

Looking back, there was one volunteer role that was particularly meaningful to Jessy: "I was a peer leader in the Newcomers Orientation Week program. The program aims to help new immigrants and refugees adjust to Canadian high schools," she reflects. "I, too, had the experience of being new in a foreign country. Every little bit of help I had along the way was very much appreciated."

The David Bentley FCPA, FCA and Janet Bentley High School Excellence Award grants \$2,500 annually to one student in Grade 12 at any Alberta school; preference is given to applicants who will need to relocate within Alberta in order to attend a post-secondary institution. Selection is based on involvement in volunteer activities, satisfactory academic achievement, and an expressed interest in pursuing a professional accounting designation.

Laying the foundation for international opportunities



Award recipient: Emily Carscadden Award: Aboriginal Student Business Award

Growing up in Lethbridge, Emily Carscadden graduated from high school with her French Immersion Diploma. With a passion for languages, she started her post-secondary education with a major in International Business and a minor in French. It wasn't until she took an introductory financial accounting class that she realized the potential of a career in accounting.

"I had a professor who highly recommended the accounting career path," says Emily. "When I found out that I could pursue accounting and still do a minor in International Business, I chose to make the switch, feeling that I had nothing to lose."

Now in her third year of university, Emily is currently in an eight-month co-op term with Deloitte in Calgary. With nothing to lose and everything to gain, Emily is optimistic about her career path towards her CPA designation: "I want to be capable of providing individuals and businesses with accurate financial information to help them make more informed financial decisions."

Receiving a scholarship from the Foundation has allowed Emily to focus on her studies, as well as her long-term goals of mastering her passion for international business. "Two years from today I see myself on an exchange program in Ecuador to complete the International Business minor of my degree."

This international exposure would not be the first for Emily. Shortly after graduating from high school, she was accepted into a yearlong Rotary Youth Exchange in Mazatlán, Mexico. "With this opportunity I was able to experience a new culture and learn Spanish as my third language."

During her exchange in Mexico, Emily participated in various volunteer experiences, such as volunteering at an orphanage. "We donated food, clothing, and medical attention to children," says Emily. "We also donated wheelchairs to the less fortunate."

The Aboriginal Student Business Award grants \$2,500 to an Aboriginal student enrolled in business or commerce at a degree-granting post-secondary institution in Alberta with a minimum 3.0 GPA at the time of application.

"There aren't enough words to describe the amazing support each and every contributor is having on myself and all other individuals impacted by this Foundation. What you are doing is paving the road for the next generation of individuals that will one day be in leadership roles that others will look up to. To put it simply, without your support, there would be many leaders and mentors not where they are today, including myself."

Business and accounting instructors might have been responsible for planting the CPA seed in Pinder Sangha's impressionable young mind, but meeting CPAs clinched the decision and inspired him to cultivate his career ambitions.

After meeting several professional and encouraging CPAs at various student networking events, Pinder's eyes were opened to the potential and pride behind the CPA designation. "Mentoring and helping others is one of the best things a person can accomplish," he says. "Receiving a scholarship from the CPA Education Foundation doesn't just impact me; this experience makes a lasting impression and I hope to one day make a difference for someone else."

Until then, Pinder is more than happy to learn as much as he can, improve his skills, and conquer one achievement at a time: "There are many amazing candidates that apply for these scholarships and to be picked as the recipient is a very humbling feeling. I feel very proud of myself and what I have achieved so far," Pinder admits gratefully.

After the successful completion of his program at SAIT, Pinder plans to enjoy a needed vacation in Europe before tackling the next step of his CPA career and making his dreams—and, eventually, the dreams of other aspiring business professionals—come true.

The Richard Schulli ca Memorial Scholarship awards \$2,500 annually to one (1) student entering his or her third or fourth year of study pursuing an undergraduate business/commerce degree with a declared major in accounting. Selection is based on involvement in volunteer activities (preferably in a mentorship role), satisfactory academic achievement in the prior year of study and an expressed interest in pursuing an accounting designation.

Growing up in Morocco, Zineb El Filali knew that her love of and talent for numbers would lead her to a career in accounting, but it wasn't until she immigrated to Canada in 2006 that she realized how big her dreams truly were.

"When I first registered at NAIT, my initial plan was to get my diploma," Zineb remembers, "but once I started the program, I became more ambitious and passionate about continuing my education. I decided to pursue my dreams of higher education and complete my Bachelor of Business Administration to become a Chartered Professional Accountant."

As the recipient of the CPA Education Foundation's 2015 New Canadian Achievement Award, Zineb hasn't stopped dreaming. "I can see myself working for a big accounting firm while doing the CPA program," says the third-year student at NAIT. This individual must be enrolled in business or commerce at a degree-granting post-secondary institution in Alberta or the CPA Professional Education Program (CPA PEP). This individual must also demonstrate satisfactory achievement in their academic or professional training program.



CPA Education Foundation conditions future CPAs through case competition

The CPA Education Foundation is proud to sponsor the CPA Alberta Board Governance Case Competition. Held annually for post-secondary students from all over the province, the 2016 Board Governance Case Competition was held in Calgary on March 16-18.

The competition, hosted by CPA Alberta and funded by the Foundation, invites teams to compete and solve a business case centered on board governance and ethics, which are important themes for Alberta's next generation of Chartered Professional Accountants. This year, teams competed from seven post-secondary institutions across Alberta, including Lethbridge, Calgary, and Edmonton.

The first day of the competition hosted a meet and greet for students and their faculty advisers appointed from each post-secondary institution. Day two consisted of a session on board governance by Dr. Chris Bart FCPA, FCA, Founder of Ontario's Directors College and recipient of the Queen Elizabeth II Diamond Jubilee Medal of Canada. Dr. Bart coached teams on the fundamentals of board governance and how best to tackle the case question.

After the session with Dr. Bart, teams were put on lockdown to work on their cases for approximately five hours. Day three began bright and early as teams presented their case solutions to a panel of CPAs and community leaders with board governance experience. Teams were judged on their identification of the issue, quality of analysis, and the clarity of their presentation. Case competitions are instrumental to helping develop students' skill sets. "The benefits of attending the competition are so much greater than the opportunity to win," says Tyler Bertamini CPA, CMA, Faculty Advisor at the case competition and Academic Mentor and Controller at North Star Contracting. "Meeting students from across Alberta and learning about board governance is like getting an entire course in governance for free, something that not many schools can offer."

The CPA Education Foundation provided generous prizes of \$10,000 for first place, \$5,000 for second place, and \$2,000 for third place. However, as Tyler Bertamini points out, the competition is an invaluable experience to all participating students regardless of the final results: it is a chance for students of various educational backgrounds and career aspirations to be exposed to accounting, to develop case analysis skills that are needed for many business courses and throughout the CPA Professional Education Program, and to practice team building and collaboration.

Project to collaborate with Indigenous communities unveiled by the Foundation

Initiative will see the Foundation create partnerships and grants to help Indigenous peoples in Alberta achieve career goals in accounting and business.

For CPA Education Foundation Executive Director Rachel Miller FCPA, FCA, partnering the Foundation with organizations working with Indigenous Albertans is a truly exciting prospect.

"Early in my accounting career, I had the chance to work with a number of Indigenous communities and support their efforts in making those communities stronger," says Rachel. "It was very inspiring to me to work with those community leaders and representatives. That's why I'm especially delighted that the Foundation is looking to collaborate with external partners to create career opportunities for Indigenous Albertans."

This new collaborative initiative is aimed at connecting with Indigenous communities and providing information and support to Indigenous peoples in Alberta interested in pursuing careers in business and accounting. Under the initiative, the Foundation will commit more than \$300,000 over two years to projects aimed at achieving the goal of improving access to this career choice.

The details of the initiative are being finalized in 2016/17, confirms Rachel. "Before we settle on any specific program, we first will connect with Indigenous associations and community leaders, as well as Indigenous centres at Alberta's degree-granting postsecondary institutions," she says. "It's these groups and organi-

zations who have the expertise and wisdom in these areas, and we will rely on their collaboration and support in delivering Foundation services under this initiative."

While the Foundation is undertaking its consultation and planning work, it has settled on the broad areas it plans to focus on during this two-year project. A threepronged approach is planned, focusing on:

- Providing grants to Indigenous centres at Alberta post-secondary institutions to help deliver services for Indigenous students in business and accounting programs;
- Partnering with a provincial association that supports Indigenous Albertans seeking educational or employment opportunities in accounting or related business fields; and
- Offering scholarships and awards to Indigenous Albertans enrolled in recognized business degree programs at Alberta post-secondary institutions.

"The theme of this new initiative is accessibility," says Rachel. "The Foundation wants to help open up access routes into the business and accounting sector for Indigenous Albertans who have career aspirations in that field. We hope that we can make a positive difference in this area."



All Alberta CPAs can support the initiative

The CPA Education Foundation relies on the encouragement and financial support of Alberta's 28,000 Chartered Professional Accountants to be able to deliver its many programs and services. For the new collaborative project with Indigenous communities, the Foundation will be asking Alberta CPAs to contribute specifically—and generously.

"I have heard from many, many Alberta CPAs who strongly support the Foundation's intention to work with Indigenous Albertans to support their aspirations for careers in accounting," says CPA Education Foundation Chair Joanne Belliveau CPA, CA, CGA. "That is why, between 2016 and 2018, we will be counting on CPAs to contribute. Our Foundation is excited and honoured to get involved in this area, and we believe all Alberta CPAs share that feeling," Joanne notes.

In 2016/17, the Foundation will provide Alberta CPAs with more information about the initiative and how CPAs can contribute to make the initiative a success. "If you're a CPA, watch your email inbox and our Foundation website to learn when and how you can support this project," says Rachel. "This initiative gives Alberta CPAs the opportunity to feel that same sense of inspiration and excitement that I feel about the Foundation's ability to make a positive impact across Alberta." Conference for Academics takes bold, new directions in accounting education

The Conference for Academics is hosted annually by the CPA Education Foundation and has become a cornerstone event that represents the Foundation's commitment to supporting accounting education in Alberta.

On May 8, 2015, accounting instructors, PhD students, and other academics gathered in Red Deer for the sixth annual Conference for Academics. This conference provides accounting instructors from all over Alberta with the opportunity to network with and hear from leaders and experts from the accounting profession. Hosted by the CPA Education Foundation, this conference has become a highly anticipated event for members of the Foundation's post-secondary community.

The day was filled with presentations, networking opportunities, and table discussion. Co-emceed by Foundation Board members Joanne Belliveau CPA, CA, CGA and Doug Wylie FCPA, FCMA the conference's theme, "Bold, New Directions," resonated with significant changes happening with unification of the accounting profession and the CPA Professional Education Program.

Some highlights of the conference included an update on the profession by Sandy Hilton FCPA, FCA from CPA Canada and Rachel Miller FCPA, FCA of CPA Alberta; Teaching Professionalism in the Classroom by Len Brooks CPA, CA; and a standards update provided by returning presenter Bob Young FCPA, FCA, who is a former partner of KPMG Canada's National Assurance and Professional Practice group in Ontario.

Back by popular demand, the day's program also featured an interactive peer group discussion that addressed topics relevant to accounting educators. Accounting instructor seeks to bridge gap between the classroom and the boardroom

The CPA Education Foundation's Innovations in Accounting Education Fund provides financial support to a wide variety of projects at the post-secondary level. These projects enhance educational opportunities, assist in delivering quality education, and provide benefits to Alberta's growing accounting profession. Dr. Sherif Elbarrad's project received funding from the Innovations in Accounting Education Fund in 2015 and is just one of the many initiatives the Foundation financially supports as part of its commitment to accounting education in Alberta.

The accounting profession might grant its members access to a variety of rewarding and lucrative careers; however, the formula that underlies this career path remains the same for every CPA: get a post-secondary education, learn the competencies, graduate, and enter the workforce. For some, however, their success in the classroom does not easily translate to the board room and Dr. Elbarrad CPA, CMA is asking "why not?"

With funding from the CPA Education Foundation's Innovations in Accounting Education Fund, Dr. Elbarrad, associate professor of accounting and Chair of the Accounting and Finance Department at MacEwan University, is embarking on a research project—"Aligning Accounting Undergraduate Education to meet the Profession's Expectations"—to decipher and fill any existing gaps between the undergraduate accounting education students receive and the expectations of their future employers. With co-researcher Dr. Mouhammad Hossain, Associate Professor in Decision Sciences & Supply Chain Management, Dr. Elbarrad is taking the lead on strengthening connections between accounting education and the business world.

"My overwhelming desire to provide the best accounting education in Alberta inspired this research." This applied study is primarily based out of the MacEwan School of Business in relation to the Alberta business community; however, the motivation behind it reflects Dr. Elbarrad's commitment to both his career and the profession. "My overwhelming desire to provide the best accounting education in Alberta inspired this research," he says.

Assessing how and if the current professional accounting competencies are preparing students for their careers could help MacEwan University refine their curriculum for students interested in following the CPA route. Ultimately, Dr. Elbarrad hopes to make a positive impact with his study by helping in the development of "a generation of accountants who are more ready to meet both professional and employer expectations."

Phase 1 of this project mainly focuses on collecting data: with the help of two undergraduate research assistants, Dr. Elbarrad has already received 100 surveys from accounting students and hopes to garner an additional 300 surveys from members of CPA Alberta who work in public practice or industry. From this data, he will investigate issues such as:

- What competencies accounting students find challenging to master;
- The discrepancies in opinion between current students and graduates regarding the usefulness of courses; and
- The kinds of expectations and professional experiences employers have had with new CPAs joining the workforce.

Once sufficient data is collected, Phase 2 will map survey results together with the current CPA competencies and curriculum at MacEwan University, which will hopefully lead to meaningful insight on what students are learning and what they need to know for today's employers. "Based on the results," Dr. Elbarrad says, "a committee will be formed to work on developing its recommendation to design a modern accounting undergraduate program that benefits students, the profession, and the business community."



Inspiring brilliant business minds: 2014 Teaching Awards
