2018 IMPACT AWARD RECIPIENT MAKES BIG WAVES FOR THE FOUNDATION

The CPA Education Foundation is proud to announce Alex Tutschek FCPA, FCA as the recipient of the Foundation's 2018 Impact Award. Each year, the Foundation has the honour of presenting the Impact Award to an individual for his or her contributions to the mission and vision of the CPA Education Foundation. It is fair to say that Alex has made some big waves when it comes to benefiting the Foundation.

Alex has been one of the Foundation's most significant supporters over the last decade. Whether as a Board member, a donor, a volunteer, a mentor, or an advocate, Alex has exemplified what the Foundation stands for—commitment to education, to the profession, and to the community.

Alex breathed life into the Foundation's No Limits initiative with a generous donation, which created five annual scholarships for Indigenous Albertans. Just as importantly, his generosity inspired others to donate to the initiative. He lent his name, image and personal thoughts to a fundraising campaign that caught the attention of CPAs across the province, which led to many CPAs making their first-ever donations to the Foundation.

During his two years as Chair, Alex devoted hundreds of hours to the work of the Foundation. This required bringing together the charitable and education-related work of three legacy bodies—a task that Alex approached with a strategic vision, strong leadership skills, and personal commitment.

Alex contributed countless hours before, during and after his time on the Foundation Board, always making himself available to talk about the Foundation with students, donors, CPAs, post-secondary representatives, and other Foundation stakeholders. THE FUTURE HAS NO LIMITS

The CPA Education Foundation has been committed to business and accounting education in Alberta for over three decades. With each year, we add to this tradition of supporting the accounting profession by looking for new ways to extend our reach into the community to make a larger, more positive impact.

The CPA Education Foundation's No Limits initiative has been the focus of fundraising efforts for the past two years. The initiative was born when obvious barriers to entry into business careers were identified for Indigenous Albertans. The goal was to fundraise \$150,000, which the Foundation would then match, allowing for \$300,000 to go towards creating opportunities for Indigenous Albertans to pursue careers in business and accounting.

At the conclusion of the Foundation's 2017/18 fundraising campaign, we are proud to say we reached our fundraising goal and now know there are no limits to the future ways we can employ these dollars to benefit Indigenous students.


In March 2018, the Foundation co-hosted the first annual Indigenous Learners Gathering with the Aboriginal Financial Officers Association of Alberta (AFOA Alberta), which would not have been possible without No Limits. The 2018 Indigenous Learners Gathering was a three-day program that united Indigenous learners, educators, and their

families to learn, share and gain a collective understanding. It helped address current challenges First Nation communities and learners face through discussions, lectures and case studies. The gathering wrapped up on a high point with a cultural celebration and performance by the Northern Cree drumming group. It was a smashing success with unanimous demand to make it an annual event.

The initiative has already allowed the Foundation to do other incredible things in addition to the Indigenous Learners Gathering, including the creation of six new scholarships for Indigenous Albertans, the development of partnerships with key Indigenous groups, and connecting the CPA profession with Indigenous communities.

The Foundation's efforts will not stop here. Although the fundraising portion of the No Limits initiative has come to a close and we are very thankful to all of our donors, it is just the beginning for opening doors for Indigenous Albertans.






Matthew Encarnacao Richard Schulli ca Memorial Scholarship




















2018 CONFERENCE FOR ACADEMICS




