

# Sample Support Documentation— Early Achievement Award

## **Supporting letters**

Thank you for taking the time to submit a nomination for a deserving candidate for the CPA Alberta Achievement Awards.

The samples provided will help you understand what details are required in the supporting documentation for a thorough package, a vital component of a successful nomination. The quantity of letters is unimportant, rather quality endorsement letters should be considered and submitted with the nomination file.

The letters of support should adequately highlight the candidate's leadership and the exceptional nature of the candidate's performance. Letters are not required for each aspect of the candidate's career presented; rather they should present evidence of specific aspects of the candidate's leadership ability and/or the exceptional nature of his/her performance. Ideally, the letters would include the following:

1. A brief description of the organization, its work and role in the community.

- 2. The details of the nominee's involvement with the organization, including:
  - · The role of the nominee
  - · Significant accomplishments
  - The actions or duties the nominee took to achieve the accomplishment
  - The time commitment (if applicable)
  - The impact of the nominee's work on the organization

## Other support materials

Any emails, media clippings or publications can also be submitted. These items can reflect the same details as above or complement the factual information provided.

### Letter of Support—Early Achievement Award Nominee

Re: Nomination of Darren Davis CPA for an Early Achievement Award

#### Dear Committee Members,

It is my distinct pleasure to support the nomination of Darren for an Early Achievement Award. There are two reasons for my support. First, mentorship—significantly contributing to the development of new CPA's technical skills and their ability to develop sound professional judgment. Second, networking (and soft skill development) with students outside the classroom and connecting them with the CPA profession.

Darren began teaching at the ABC University part-time while working in public accounting. Darren enjoyed the teaching experience so much that he joined us full time at the University. Darren wanted to be an educator and help develop the next generation of CPAs by imparting sound technical knowledge and by serving as a mentor and role model of how to conduct oneself professionally as a CPA.

Darren has taught many courses from introductory accounting, tax, and MBA level financial accounting. These courses are technically demanding, require frequent updating, and yet have been well received by students. Darren won the MBA Mackenzie Teaching Award in 2020, which is quite unusual since MBA students usually do not major in accounting, and do not choose accounting professors for MBA teaching awards.

During the pandemic, Darren helped teach an overload of classes to cover for a colleague who was ill and has engaged in teaching an additional series of weekend boot camps to enhance student familiarity with accounting software, data analytics tools such as Power BI, and even case studies based on real company data and scenarios. Darren is dedicated to the development of the highest level of technical knowledge for students aspiring to become CPAs. Darren is deeply engaged with students outside the classroom. He:

- · has sponsored student scholarships;
- chairs an alumni engagement committee;
- coaches students for case competitions—ABC's student team has won 1st prize in the CPA Alberta case competition for the last three years;
- has engaged with student run conferences (JDC West, RMBS); and
- has reached out to high school students through NXT GEN with an EDI (Equity, Diversity, and Inclusion) focus especially on reaching out to LGBTQ2S+ students.

Darren also engages with CPA Alberta and the CPA Western School of Business and has served as the MC at the CPA graduation ceremonies in Edmonton and Calgary. Students meet Darren in class, in weekend boot camps, in preparation for case competitions, at student-run conferences, and even at CPA graduation ceremonies.

Darren is a proud CPA who is an excellent role model for accounting students and brings stature and honor to the CPA profession. I strongly support Darren's nomination as a very deserving candidate for an Early Achievement Award.
