Briefings for your personal and professional success.



With summer in full swing, you and many of your CPA colleagues are taking much-deserved time away from the office. But are CPAs really "recharging" on vacation? If your answer is "no," you are not the only one.

To find out more about Alberta CPAs' vacation habits, an informal poll was held during CPA Alberta's recent Elevate Your Mind Professional Development conference. Visitors to the CPA Assist booth at Elevate Your Mind were asked "how often do you stay connected to work during your vacation?"

CPAs stay connected

The results showed 77 per cent of respondents connect to the office even during their vacation, with almost 40 per cent saying they check-in with work often or always. That is strikingly higher than the population at-large: according to surveys by Robert Half, 35 per cent of Canadian employees connect with work at some point during their vacation and 65 per cent do not. Within the professional realm specifically, 56 per cent said they'll maintain some contact with work, making CPAs standout even when compared to other professionals.

More data comes from Captivate Office Pulse Research, which collected data from North American professionals in top markets to find out their vacation plans.

Unplugging from office responsibilities

A key finding of those surveyed by Captivate was that Canadian professionals are able to unplug and enjoy their vacation time

to the fullest. Only 23 per cent of participants surveyed would work for 30 minutes a day while on vacation, while 68 per cent say they wouldn't work at all.

Average vacation days taken

24 per cent of Canadian respondents planned on taking six to ten days for summer vacation, while 32 per cent planned to take off ten or more days. The survey also found that the most popular time to take summer vacation was August. However, Canadian female professionals preferred taking their holiday in July.

Rest and relaxation

Canadians really enjoy unwinding and relaxing—68 per cent of respondents reported that their plans for summer vacation included rest and relaxation. With 52 per cent, the second most popular activity was spending time with family.

Regardless of vacation plans, the best advice is simply take some. While there may be valid reasons for connecting to the office while away, it is important to remember that vacations are not only enjoyable, but beneficial. They have been proven to reduce stress, decrease burn out, and increase happiness. So, strive to make the most of this year's summer vacation season!

As well, you must complete 120 hours of PD over a three-year rolling cycle, of which 60 hours must be verifiable. This ensures that CPAs are learning new technical competencies, growing their professional and personal skills, and bringing these valuable skill sets to their work roles. Vacation time can be a great opportunity to utilize downtime to meet your PD requirements. Here are some quick and easy ways to incorporate PD into your summer vacation.

Online learning

For many people, in-person classes might not be possible with time constraints, which is why some CPAs prefer the flexibility of online learning. CPA Alberta offers a variety of courses to suit all needs. Online classes let you work at your own pace from the comfort of your own home! LIFETIME ACHIEVEMENT AWARDS

The Lifetime Achievement Award formally recognizes Fellows of the Chartered Professional Accountants who have continued to render exceptional services to the profession or whose achievements in their careers or in the community have earned them distinction and brought honour to the profession.



Harold Kingston FCPA, FCA

Since earning his designation in 1975, Harold has continued to share his expertise and add value to organizations and those around him. He has had an outstanding professional career, growing his distinguished skillset at Kingston Ross Pasnak (KRP) LLP. Until his retirement as a partner in 2017, Harold used his talents to lead and build KRP into one of Edmonton's most successful and well-respected mid-sized firms.

Outside of his vast career achievements, Harold has brought his drive and commitment to a variety of noteworthy organizations. His deep-rooted dedication has seen him participate in a number of significant committees and boards to help advance the profession, such as the Professional Conduct Committee, Discipline Tribunal Roster, Joint Standards Directorate, and Recognition Committee.

It is in his extensive community volunteer roles where Harold also truly shines. Harold exudes the same leadership, determination, and professionalism in these roles that have set him apart in his career. Harold's broad scope of work on Northlands' Board of Governors, MacEwan Community College (now MacEwan University) Board, and the Canadian Breast Cancer Foundation Board, among others, helped these organizations reach new levels of success.

In 2012, he was made a Fellow of the Chartered Accountants of Alberta (FCA). Merwan has always been actively engaged in the profession, and has volunteered in a number of ways, from sharing his expertise on many national and international groups to recounting his personal story with post-secondary students considering an accounting career.

Specifically, Merwan's service has included the Canadian Council of Legislative Auditors, the Public Sector Accounting Board Task Force on Indicators of Financial Condition, as well as a study group on accounting bases used in Canadian government budgeting. Currently, he is a member of CPA Canada's Public Sector Accounting Board Conceptual Framework Task Force. At the international level, Merwan has provided mentorship and guidance to other governmental auditors in an effort to ensure key learnings are shared on efficiencies in performance auditing.

CPAs AND A GIVING MINDSET

Marc Joiner FCPA, FCA is a partner at Deloitte in Calgary. He was awarded Fellowship this year in recognition of his achievements in the community, the profession, and his career. In this article, Marc shares his passion and reasons for giving back to the community, in hopes of inspiring his CPA colleagues to do the same.

IT WAS AN UNEXPECTED AND HUMBLING

honour to be recognized this spring as a Fellow of the Chartered Professional Accountants. That honour was not bestowed on me because I am a smart CPA, but more so because of the impact that my giving mindset has had in the broad community and, partially through that mindset, how I have represented the profession well. This giving mindset has been pervasive throughout all facets of my life, including unselfishly helping clients, assisting Deloitte colleagues and staff, and, perhaps most importantly, my contributing of time, energy, and money to organizations in which my family and I believe.

We CPAs do not often speak of this last element—our opportunity as CPAs to invest as leaders in the communities in which we live. Early in my career, I made a conscious decision that being fulfilled included giving back to the community. As to be expected, my giving has changed significantly over my career. Early on (and for many years), it was \$50 and some volunteer time, but as my income increased and I built skill-sets and personal networks that were more valuable to organizations, my investment of both money and time increased. For example, like many others, my family and I have invested for quite a few years as United Way Major Donors—a significant increase from the \$50 of earlier days.

What's important, especially early in a career, is not the amount of support given, but the building of the giving mindset and the habit of contributing regularly. Therefore, I encourage all CPAs to identify a charity of choice and start to give time, energy, and money, even if they are small to start, and to increase those investments when the situation arises to make that possible.

I use the word "investment" deliberately when speaking of philanthropy. I currently co-chair the Calgary United Way's Major Donor Cabinet, which is responsible for all personal donations over \$10,000 and last year raised \$21 million to support the work of the United Way. It is certainly an investment back into our community, as I believe that the money we raise has a tangible, significant, and enduring positive impact on the lives of so many (in this case of the United Way, going to support 152,800 Calgarians in 2017!).

Philanthropic activities are also an investment for me personally. They increase my personal networks in the business community that, frankly, yield tangible dividends for me as a partner at Deloitte. It is acceptable to speak of this. Philanthropy does not have to be simply altruistic; it is okay for you as a CPA to receive a return for the time and money that you invest.

However, you need to have a passion for the cause underlying the organization in which you invest. In my case, our family invested in the past directly into singlepurpose organizations, but in the last 10 years we have focused almost exclusively on investing time and money into the United Way. We believe profoundly in the United Way's mission to mobilize communities for lasting social change and its unique position as a catalyst bringing together organizations across sectors to proactively solve complex social issues. By focusing on the root causes, as the United Way does, we as a community avoid significantly higher costs to society in the future than we would by simply addressing the symptoms of issues that can be avoided proactively.

A giving mindset must be prevalent in order to prioritize the time to devote to not-for-profits. People have often asked me how I make time to invest time in charitable organizations despite being married with four kids, having a demanding career, and being a passionate and very active cycler, runner, and skier. My response is always the same: I need to create the capacity for such investments of time, as I believe that I need to give back to the community. You, too, have time to invest if you make it a priority.

I will leave you with a few questions to ponder:

- How can you invest your time, energy, and money into a worthy not-for-profit organization?
- What charitable organization(s) resonates for you and why?
- What impact can you have in your community?
- How can you best represent CPAs in the community?

I hope that a thoughtful consideration of these questions will serve as a first step in your journey to a giving mindset! **D**

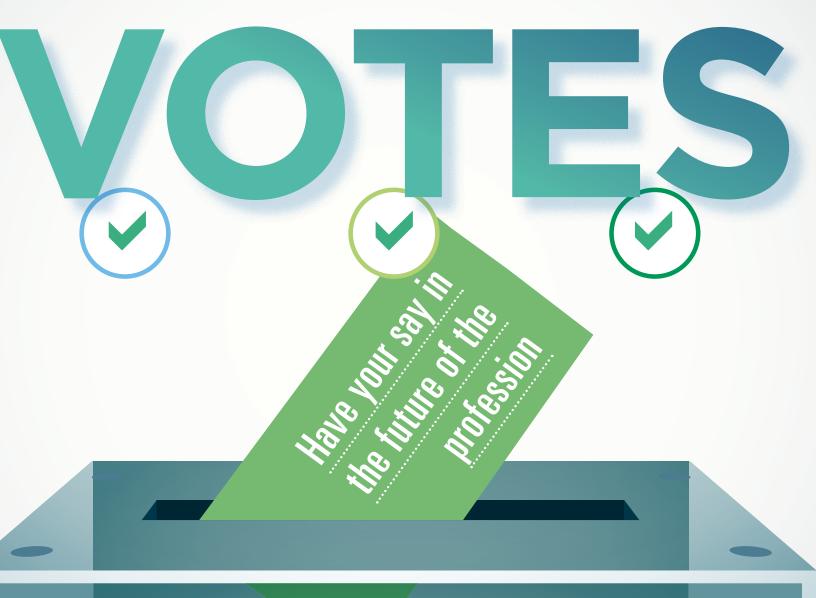

Each year, Alberta CPAs get their chance to influence the future of the profession by casting a ballot. There are two distinct votes: for CPAs to serve on the CPA Alberta Board and on proposed changes to CPA Alberta's governing documents (including any changes to the Bylaws, Rules of Professional Conduct, and Regulations).

The voting period for 2018 will be from August 22 until September 18. All CPA Alberta members in good standing are eligible and encouraged to vote. This year, votes will be held to fill one open position on the CPA Alberta Board and on five proposed changes to the CPA Alberta Bylaws.

The CPA Alberta Board consists of 12 members —nine CPAs and three public representatives appointed by the Government of Alberta. The CPA Alberta Board governs the business and affairs of the organization, and helps ensure CPA Alberta meets its mandate under the *Chartered Professional Accountants Act*. Specifically, the Board provides leadership and oversight to the organization's mission, vision, operating principles, strategic plan, and annual operating plan, in conjunction with the Chief Executive Officer.

CPA Alberta Board members are the bridge between individual members and CPA Alberta, giving voice to all Alberta CPAs. Board members share and discuss the challenges and opportunities that face the profession and its individual members, in order that CPA Alberta can address these factors to protect the public interest and help its members succeed. Therefore, it is critical that Alberta CPAs take the time to assess the candidates running for the board, and cast an informed ballot for the individual they believe would best serve the profession.



Alberta CPAs are running for board election

This year, the term of one CPA Alberta Board member is ending, meaning there is one open position on the CPA Alberta Board. Typically, three members of the Board have their terms ending; however, this year, two of those individuals whose terms are ending hold the positions of Chair and Vice Chair, respectively. As such, they are not required to stand for reelection and may serve a total term in excess of the standard six years. This provision of the CPA Alberta Directives helps to ensure that board members who take on executive roles are experienced and have familiarity with CPA Alberta issues and processes.

Proposed Bylaw Changes

Changes to the profession's governing documents

CPA Alberta's governing documents outline and provide the framework for the authority of the organization, and the rights and responsibilities of all CPAs. Changes to the CPA Alberta Regulations, Rules of Professional Conduct, and Bylaws can only be made with the approval of Alberta CPAs.

For 2018, there will be five proposed changes to the CPA Alberta Bylaws for consideration. These changes will provide additional clarity but will not result in substantive alterations to the Bylaws or impact Alberta CPAs greatly.

CPA Alberta Proposed Bylaw Changes 2018:

The proposed changes to the CPA Alberta Bylaws that are being put to Alberta CPAs in 2018 are:

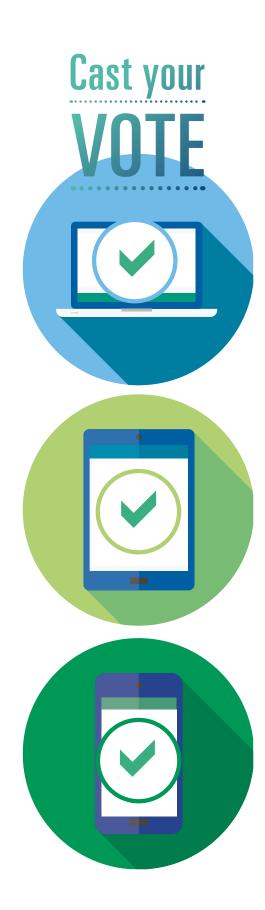
- Bylaw 261: changing subparagraph (b)(i) to its own paragraph (c).
- Bylaw 265: adding the numerical symbol "2" adjacent to the written-word two in order to make it consistent with the formatting of other bylaws
- Bylaw 1322: re-wording to make the wording of the bylaw more consistent with its intent—to allow for immediate and automatic suspension of a CPA Alberta member's professional accounting firm (PAF) or professional service provider (PSP) registration if the member has been suspended or cancelled for any reason
- Bylaw 1557: expanding the scope of the online legal research databases CPA Alberta can send tribunal decisions and sanction agreements to by eliminating a specific reference to the Quicklaw online legal research database
- Bylaw 1902: correcting the lettering of the paragraphs of the bylaw, as the current version contains two paragraphs lettered "e"

The full text of the bylaw changes will be available on the CPA Alberta website as part of the CPA Alberta vote.

A reminder to practitioners that these two guides do not amend or override auditing or review standards, or address all reporting changes resulting from the auditing and review standards. Guidance on accounting for investments available

Draft framework for reporting on performance measures

On June 14, the Accounting Standards Board issued the Draft Framework for Reporting Performance Measures and is planning the upcoming release of the CSA Rule over Key Performance Indicators (KPIs) and requires auditor feedback.

The Framework is the initial step in responding to the needs of stakeholders—including investors, contributors, lenders and other resource providers—about the performance measures reported by entities. You are invited to join the discussion and help improve financial and non-financial performance measures reported outside of financial statements.

Read and comment on the Framework by September 17. CPA Canada and AASB staff are seeking participants for roundtable discussions focused on this topic, taking place in August and October 2018. You can register online at the CPA Canada website by searching "performance measures roundtable discussion call for auditors."

The following are some highlights of the draft framework:

Why do we need a Framework?

Financial statements provide a strong foundation for financial reporting. But there's more information that users consider, including performance measures, when making investing, contributing, lending, and other resource allocation decisions. The ACSB heard from stakeholders: investors, contributors, lenders and other resource providers to management, directors, and assurance providers and wants to address some concerns stated, including:

- The quality of performance measures being reported.
- The lack of consistency, transparency, and comparability of performance measures reported period to period.
- The "expectation gap" about the governance practices of entities over how performance are developed and reported, and whether those measures are subject to assurance.
- The limited guidance available on how to develop and report performance measures not usually subject to assurance.

What are performance measures?

Performance measures range from measures under GAAP to non-financial or operational measures. This Framework provides guidance on reporting performance measures outside of GAAP.

About the Framework – Developing and Reporting a Performance Measure

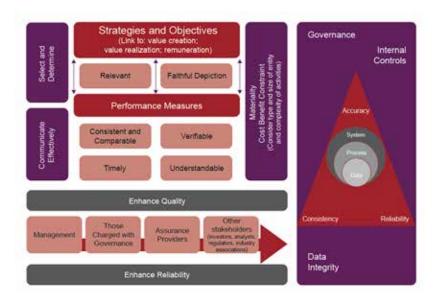
An entity needs to look to its strategies, goals, and objectives to identify its key activities—both those it has already done, and those it will do, to generate value. These strategies, goals, and objectives help identify the information an entity wants to report on, in addition to the information reported in its financial statements. The Framework for Reporting Performance Measures provides guidance on how an entity can develop or construct a performance measure, a process broken down into principles or building blocks.

Performance Measure Principles

Next Steps

The AcSB will:

- consider comments received and issue a revised Framework;
- work with others to encourage application;
- review and update the Framework, as needed; and
- assist others in developing additional guidance, such as industry-based guidance and Q&As.

Cooperation with Practice Review

Assessing a firms' compliance with professional standards or, what is commonly known as "practice review"—is part of CPA Alberta's regulatory process and plays an essential role in protecting the public. It does so by taking appropriate follow-up or remedial action in instances of non-compliance and by providing one-on-one education to firms.

Rule 104 of CPA Alberta's Rules of Professional Conduct obliges a registrant to co-operate with all of CPA Alberta's regulatory process. With Rule 104 in mind, it is important for registrants to communicate promptly and openly with CPA Alberta's Practice Review Department during all aspects of a practice review. For those involved in the practice review process, the following timeline may be helpful in preparing for a review and understanding expectations.

Approximately four to six months prior to the anticipated practice review date, firms due for practice review are sent emails requesting completion of the scheduling and tax management questionnaires. Firms are given a three week deadline to complete these questionnaires. The scheduling questionnaire provides important information in scheduling the practice review and is requested well enough in advance of the review in order to allow sufficient time to coordinate an efficient review. This allows CPA Alberta to take into considering elements such as firm's and practice reviewer's availability and associated travel costs.

If a firm experiences difficulties in completing these questionnaires within the required deadline, it is important to communicate these difficulties to CPA Alberta. Without that communication, if the firm does not respond to follow-up enquiries of the Practice Review Department, questionnaires which are not completed within the required timeline may cause the firm to be considered in breach of Rule 104. In that case, a complaint of unprofessional conduct regarding lack of cooperation with regulatory processes may be put forward. There is another practical benefit in promptly responding to the questionnaires, in addition to compliance with Rule 104: those who respond first are given more options in determining their practice review dates.

Approximately two to three months prior to the anticipated review date, a mutually agreed upon date for practice review is finalized. After this date is agreed upon, there are generally no further changes to the scheduled review date. If a firm refuses to agree upon a practice review date or does not respond to CPA Alberta's attempts to schedule the review, the firm is in breach of Rule 104 with, again, an eventual consequence being that a complaint of unprofessional conduct regarding lack of cooperation with regulatory processes may be put forward.

Understandably, extenuating circumstances may arise after agreeing upon a date, necessitating a change. In such circumstances, it is important to contact CPA Alberta as soon as possible so that the situation can be discussed and the practice review can be rescheduled if necessary.

Consequences of not cooperating with the practice review process that result in a complaint can result in findings of unprofessional conduct against registrants. Recent decisions of the CPA Alberta Discipline Tribunal, illustrate the consequences of such a finding. Sanctions for failing to cooperate with the practice review process have included: i) a finding of unprofessional conduct which, thereafter, forms part of a registrant's permanent disciplinary history; ii) the publication of disciplinary decision and the finding of unprofessional conduct being posted on the CPA Alberta website for a minimum of three years; iii) the issuance of a written reprimand that is retained on a registrant's file; iv) fines; and; v) the reimbursement of CPA Alberta's costs associated with the complaint process, which can be substantial.

Timely and open communication with CPA Alberta during all aspects of a practice review is the key. This communication will not only ensure compliance with Rule 104, but will also facilitate a more efficient practice review.

Meeting Public Accounting Requirements

In order to register a professional accounting firm (PAF) in Alberta, Alberta CPAs must meet the education and practical experience requirements in place for each category of registration in which they wish to engage. While many CPAs meet the education component of these requirements when they earn their CPA designation, not all CPAs complete the required education components for areas they want to engage in at the time of certification. The post-designation public accounting (PDPA) program offers a way for Alberta CPAs who attained their designation without completing the education components for the public practice requirements the ability to meet this requirement post-designation.

Specifically, PDPA is for CPAs who did not complete their assurance or taxation component modules for public practice rights at the time of certification, but are looking to register to provide:

- Audit or Review services: the PDPA module and exam, which is comprised of assurance, taxation, financial reporting, finance, and strategy and governance, will meet the education component for the Varied Registration categories of Audit, Review, Compilation, and Other Regulated Services - Taxation.
- Compilation or Taxation services: the PDPA-Tax module and exam will meet the education component for the Varied Registration categories of Compilation and Other Regulated Services – Taxation.

As well, under the new Mutual Recognition Agreement (MRA) with the US International Qualification Appraisal Board, any Canadian CPA seeking admission to a US State Board of Accountancy listed as part of the MRA will need to have completed the audit level education requirements. Therefore, any Canadian CPA member who is seeking admission to membership with a US State Board under the MRA but has not completed the education component for audit at the time of certification will need to complete the PDPA module and exam.

Who needs to take these courses?

If you are a CPA who has not completed the assurance and taxation education components prior to certification and would like to offer assurance level services, you will be required to complete the PDPA course and exam.

If you are a CPA who has not completed the taxation education component prior to certification and would like to offer compilation or taxation services, you will be required to complete the PDPA-Tax course and exam. If you are a CPA who has not completed the assurance and taxation education components prior to certification and would like to apply under the MRA with any US State Board of Accountancy noted under this agreement, you will be required to complete the PDPA course and exam.

Who is already deemed to have met these requirements?

Those CPAs who meet any one of the following criteria are deemed to have met these requirements through their education programs and therefore do not have to take the PDPA courses to register a PAF:

- a CPA who has certified through the CPA education program and has completed the Assurance and Taxation electives and successfully completed the Common Final Exam (CFE) demonstrating a depth of financial reporting and assurance;
- a CPA who has certified through the legacy CMA education program and has completed Audit I, Audit II, Tax I, Tax II, and Tax III;
- a CPA who has certified through the legacy CGA education program and has completed Audit 2 and Taxation 2; or
- a CPA who has certified through the legacy CA education program
