

UNDERTAKING

TO: **CHARTERED PROFESSIONAL ACCOUNTANTS OF ALBERTA**
("CPA Alberta")

RE: Undertaking not to practise as a Chartered Professional Accountant ("this Undertaking")

I, Patrick Stephen Bieleny, CPA, CA, hereby irrevocably undertake not to practise as a Chartered Professional Accountant until the full and final resolution of the Court proceedings that arose as a result of criminal charges against me and filed under Docket No. 1903 40729P1. I acknowledge and agree that:

- (a) "practise as a Chartered Professional Accountant" includes, but is not limited to, the following:
- representing myself as a member in good standing with CPA Alberta;
 - performing accounting services, except for a corporation of which I am a 100% shareholder;
 - holding or handling funds or property of any kind in trust, as set out in Rule 612 of the Rules of Professional Conduct of CPA Alberta ("the Rules"), except for acting as an Executor for the estate of a deceased member of my family ("Estate"), provided that, in such case:
 - I acknowledge that, under Rule 612.15, CPA Alberta or its appointee is authorized, at its discretion, to review my records in respect of any such Estate to ascertain compliance with the Rules; and
 - I shall provide to all beneficiaries of any such Estate an executed copy of this Undertaking forthwith upon the later of (1) execution of this Undertaking, or (2) my role as executor being triggered by the passing of such a family member;

and

- (b) "full and final resolution" shall consist of conviction, plea agreement, acquittal, Crown Stay, Judicial Stay, withdrawal of charges or combination thereof, and, in the event of conviction or acquittal, this Undertaking shall remain in full force and effect until all rights of appeal have expired or been exhausted, as the case may be.

I also hereby undertake to inform any person who, during the time that this Undertaking is in effect, enquires about my registration status – including requests for me to conduct any accounting services, which, I acknowledge, I am prohibited from accepting – about the existence and limitations of this Undertaking.

I hereby acknowledge that CPA Alberta will publish a notice of this Undertaking – including my name and the scope of this Undertaking – on the CPA Alberta website while this Undertaking remains in effect.

I also hereby commit and undertake to make the necessary information available to CPA Alberta in order for them to verify that I am complying with this Undertaking when requested to do so.

This Undertaking is being made to CPA Alberta pursuant to the May 17, 2019 letter in which my legal counsel indicated my willingness to enter into an undertaking of this nature.
